## Pricing Options, January 2019

### Option 1: Pay as You Learn (PAYL)

Key features:

- Our most popular option – breaks payment down into a deposit and regular monthly instalments
- No credit check is required
- You pay for the Diploma as you go, meaning that if you decide to leave the Diploma programme prior to completion, you don't have to keep paying
